#### **SCHOOLING**

**Dressage:** Only permitted in designated competition and warmup rings.

**DSHB:** Only permitted in ring on west end of Barn E.

FRIDAY: Schooling permitted until 8:00 pm in competition rings and warmup areas. SATURDAY: Schooling permitted around outside of dressage rings at lunch break and after classes end until 8:00 pm. Schooling in designated warmups until 8:00 pm.

### **SHOW OFFICE and CONCESSIONS**

Show office is located inside main coliseum. Concessions on Saturday and Sunday.

## **FACILITY and SHOW RULES**

- 1. No dogs in Coliseum.
- 2. No glass containers on grounds.
- 3. Lungeing only in designated lungeing area. No lungeing in warm up rings or pads.
- 4. All coaching must be done from outside edge of warmup areas.
- 5. Manure in designated receptacles. No cleaning trailers in parking lots.
- 7. Medical waste in sharps containers only.
- 8. Barn aisles must remain clear of trunks, hay bales, etc.
- 9. Fire access to barns must not be blocked at any time.
- 10. No nails or screws can be used in barns or stalls.
- **11. Face covers required only for UNVACCINATED people inside buildings.**

#### **USEF RULES**

- 1. Numbers must be worn at all times when a horse is being exercised or ridden.
- 2. DOGS MUST BE ON LEASHES or otherwise contained AT ALL TIMES WHILE ON SHOW GROUNDS (INCUDING IN STABLE AREAS).

#### **HEADGEAR RULE FOR DRESSAGE and DSHB**

From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds, including non-competing riders, riders on non-competing horses, and those competing in all classes and tests, including Para-Equestrian tests, must wear protective headgear as defined by this rule and otherwise in compliance with GR801. Any rider violating this rule at any time must immediately be prohibited from further riding until such headgear is properly in place. USEF DR120.6. DSHB handlers, assistant handlers and whip assistants of any age must wear protective headgear as defined by this rule and otherwise in compliance with GR801 while handling or assisting in the competition ring.

Protective headgear is defined as a riding helmet which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. The harness must be secured and properly fitted. Unless jackets are waived, while in the competition ring, exhibitors wearing protective headgear must wear a short, dark jacket, dark tailcoat (only permitted for tests above Fourth Level), or Armed Services or police uniform (if eligible), dark hatcovers (where applicable) and must otherwise conform to DR120 (see GR801).
